Therefore, willfully intervening to end the development of human life at any stage is usurping God's authority over human life.

The \_\_\_\_\_ of \_\_\_\_\_ do not change the fact that the child's life is sacred because they are made in the image of God; they are "innocent blood," and only God has the authority to take their life.

*...when Gentiles, who do not by nature have the law, (instinctively) do what the law demands, they are a law to themselves even though they do not have the law. They show that ~~the work of~~ (the code of conduct required by) the law is written on their hearts. Their consciences confirm this. Their competing thoughts either accuse or even excuse them... - Romans 2:14-15*

*And because they did not think it worthwhile to acknowledge God, God delivered them over to a corrupt mind so that they do what is not right. - Romans 1:28*

Universal moral law demands we show \_\_\_\_\_ care, not \_\_\_\_\_, toward those who are vulnerable and weak.

*People were bringing little children to him in order that he might touch them, but the disciples rebuked them. When Jesus saw it, he was indignant and said to them, "Let the little children come to me. Don't stop them, because the kingdom of God belongs to such as these. Truly I tell you, whoever does not receive the kingdom of God like a little child will never enter it." - Mark 10:13-15*
